Pennock City Council held their regular monthly meeting on Tuesday, February 4, 2025 at 7:00 p.m. at the Pennock Community Center. The following members were present Mayor Kevin Crowley, Council member Jeff Arends, Bruce Bastin, Lance Crowe and Shane Dillabough. Also present was Mark Johnson, maintenance employee Donovan Peters, resident Kerry Gross and Deputy Meghan Dimler.

Motion by Council member Bastin to accept the agenda as presented; Council member Dillabough seconds the motion. The motion passed.
