

Pennock City Council Meeting  
Tuesday, July 1, 2025

Pennock City Council held their regular monthly meeting on Tuesday, July 1, 2025 at 7:00 p.m. at the Pennock Community Center. The following members were present Mayor Kevin Crowley, Council members Jeff Arends, Bruce Bastin, Lance Crowe and Shane Dillabough. Also present maintenance employee Donavan Peters, Deputy Meghan Dimler, David Euerle with Westberg Eischens, PLLP, Mark Johnson and residents Jim Kidrowski, Darwin and Jenni Thorpe and Cory Jorschumb.

Mayor Crowley called the meeting to order at 7:00 p.m.

Motion by Council member Bastin to accept the agenda as presented; Council member Dillabough seconds the motion. The motion passed.

Motion by Council member Arends to approve the Consent Agenda which consisted of the June 3, 2025 Council minutes and to pay all the July claims; Council member Crowe seconds the motion. The motion passed.

He mentioned that in the general fund, revenues have exceeded expenditures 4 out of 4 years. In the water fund, had an operating loss 3 out of the last 4 years. The sewer fund is operating at a loss.
