

Pennock City Council Meeting  
Tuesday, May 5, 2020

Pennock City Council held their regular monthly meeting on Tuesday, May 5, 2020 at 7:00 p.m. at the Pennock Community Center. The following members were present Mayor Kevin Crowley, Council members Bruce Bastin, Mackenzie Laughlin and Laurie Maresch. Absent was Jeff Arends. Also present was Donavan Peters.

Mayor Crowley called the meeting to order at 7:00 p.m.

Motion by Council member Laughlin to accept the agenda as presented; Council member Maresch seconds the motion. The motion passed.

Motion by Council member Maresch to approve the Consent Agenda which consisted of the April 7, 2020 Board of Appeal and Equalization meeting minutes and the April 7, 2020 Council minutes and to pay all the May bills, Council member Bastin seconds the motion. The motion passed.

Deputy Levi Brown was not present for the sheriff's report but did provide the report to Clerk Johnson. For the month of April there were 49 hours.

*Pennock City Wide Clean-up Day* – Council member Laughlin made a motion that clean-up days will be Saturday, May 16<sup>th</sup> from 7:00 a.m. – 3:00 p.m. for **City of Pennock residents only**. All residents need to check in prior to dumping, they need to unload their own loads themselves but City maintenance employee will be available for larger items, there will be a \$25 charge for TV's and computer monitors and flyers will be handed out letting residents know about changes that will happen in 2021, Council member Bastin seconds the motion. The motion passed.

*Pennock City Wide Garage Sales* – Council member Bastin made a motion not to have a Spring City Wide Garage sale, Council member Laughlin seconds the motion. The motion passed.

*Street sweeping* – It was decided not to do this spring.
