

Pennock City Council Meeting
Tuesday, October 4, 2022

Pennock City Council held their regular monthly meeting on Tuesday, October 4, 2022 at 7:00 p.m. at the Pennock Community Center. The following members were present Mayor Kevin Crowley, Council members Jeff Arends, Bruce Bastin and Dave Miller. Absent was council member Karen Skaggs. Also present was Donavan Peters, Deputy Riley Kampsen, Sarah Swedburg with Kandiyohi County & City of Willmar Economic Development Commission (EDC), resident Kerry Gross and Abigail Reinhart.
