

Pennock City Council Meeting
Tuesday, September 6, 2022

Pennock City Council held their regular monthly meeting on Tuesday, September 6, 2022 at 7:00 p.m. at the Pennock Community Center. The following members were present Mayor Kevin Crowley via zoom, Council members Jeff Arends, Bruce Bastin, Dave Miller and Karen Skaggs. Also present was Donavan Peters, residents Darwin and Jenni Thorpe and Abigail Reinhart.

Deputy Mayor Bastin called the meeting to order at 7:00 p.m.

Motion by Council member Arends to accept the agenda as presented; Council member Miller seconds the motion. The motion passed.

Motion by Council member Miller to approve the Consent Agenda which consisted of the August 2, 2022 Council minutes and to pay all the September bills; Council member Arends seconds the motion. The motion passed.

Deputy Riley Kampsen was not present for the sheriff's report but did present the report to Clerk Johnson. For the month of August there were 45 hours.
